Electronic Clinical Quality Measures (eCQMs) Annual Update Pre-Publication Document for the 2024 Reporting/Performance Period

February 2023

This document describes the versions of the standards and code systems used in conjunction with the updated eCQMs for potential use in the Centers for Medicare & Medicaid Services (CMS) programs for the 2024 reporting/performance period. It is designed to help health information technology (IT)/electronic health record (EHR) developers, Eligible Clinicians, and Eligible Hospitals/Critical Access Hospitals prepare for 2024 reporting through transparent prerelease of the expected standards and code system versions.

Where and when to obtain updated eCQMs for 2024 reporting/performance period:

The eCQM annual update for the 2024 reporting/performance period will be available Spring 2023. Please sign up for and follow the <u>Electronic Clinical Quality Improvement (eCQI) Resource Center</u>, and <u>CMS</u> listservs to receive updates and announcements on the eCQM specifications' publication and related content.
