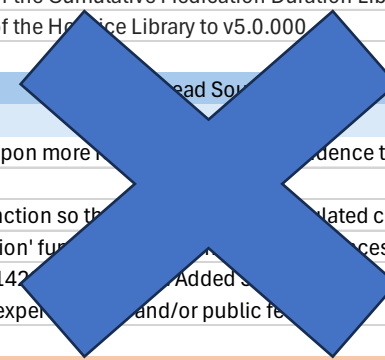

MEASURE COLLABORATION CONCEPTS

- 1. Measure Concepts In-Progress** - concepts (or data elements) under development (posted on MMS Hub) that measure developers are seeking feedback on behalf of CMS or another federal agency.
- 2. Measure Concepts Under Consideration** - concepts CMS/federal agency is considering for which no contracted work has started or work measure developers have begun preliminary work on i.e. environmental scan /lit review. These concepts are to be provided by CMS, other federal agencies and/or measure developers to the eCQI RC for posting of the concept/data element within the Measure Concepts module.
- 3. New Measure Concept** – concepts submitted by the public for which CMS has not seen.

OPEN DISCUSSION ITEMS

- Under Eligible Hospital Inpatient eCQMs, have you considered putting Hybrid measures in their own category - while these measures are in the IQR but are also scheduled to show up in new programs such as the TEAM Model and MBQIP?
 - *Resource Center (RC) team responded they will bring to CMS for consideration.*
- Question about highlighting hospitals that have tested eCQMs as a resource for other hospitals.
 - *RC team responded with highlighting the Jira links on each individual measure specification page as a resource to questions asked and answered as hospitals did not want their names out there.*
 - *The responses to those tickets should be summarized and confirmed as communications directly from CMS.*
 - *Shouldn't be dependent on me reading tickets.*
- Is there a way to download the codes used in the ePC07 to use to validate for the cases - severe obstetric complications
 - *RC team responded only in the NLM's VSAC due to code system copyright issues. <https://vsac.nlm.nih.gov/>*
- Do all eCQMS have flows for EC too?
 - *RC team responded that they do.*



OPEN DISCUSSION ITEMS (CONT.)

- Where can I find about submission requirement for 2025 for OQR eCQMs ?
- Is there a place with a list of all eligible and mandatory eCQMs?
- Where can you look to see when the eCQM measures are optional or mandatory?
 - *RC team responded that these questions are specific to CMS quality programs and end users need to review the program websites directly.*
- Are there simple detail spec sheets available without all of the complicated details? A short handout just to show the basics of the measure
 - *RC team responded there are overviews for the claims-based measures and they will share ask with CMS.*
- Consensus Based Entities - how do we follow them? Is their contact information available on the eCQI?
 - *RC team demonstrated where the links to the CBE information is on the eCQI Resource Center.*
