### CMS Quality Reporting Program Using eCQMS

- CMS publishes eCQMs for inclusion or potential inclusion in several quality reporting programs:
  - Advanced APM: Primary Care First (PCF)
  - Hospital Inpatient Quality Reporting (IQR) Program
  - Hospital Outpatient Quality Reporting (OQR) Program
  - <u>Medicare Promoting Interoperability EHR Incentive Program for</u> <u>Eligible Hospitals and Critical Access Hospitals</u>
  - <u>Medicare Shared Savings Program: Accountable Care</u> <u>Organizations (ACOs)</u>
  - Quality Payment Program: The Merit-based Incentive Payment System (MIPS) and Advanced Alternative Payment Models (Advanced APMs)





# Quality Reporting Document Architecture (QRDA)

- The QRDA is the data submission standard used for a variety of quality measurement and reporting initiatives. It creates a standard method to report quality measure results in a structured, consistent format and can be used to exchange eCQM data between systems.
- A Health Level Seven International® (HL7) Clinical Document Architecture (CDA)-based standard, which further constrains CDA Release 2 for exchange of eCQM data.
- CMS publishes <u>QRDA Implementation Guides (IGs)</u>, <u>Schematrons</u>, and <u>sample files</u> annually to provide technical guidance for implementing the HL7 QRDA standards for reporting to CMS quality programs.

### QRDA (Cont'd)

 QRDA was adopted by ONC as the standard to support both QRDA Category I (individual patient) and QRDA Category III (aggregate) data submission for quality reporting. This figure depicts the use and flow of the eCQM transmission standards.




### Testing QRDA: CMS QRDA Pre-Submission Validation Tools

- <u>Cypress</u> QRDA validation tool
  - The Cypress QRDA validation tool provides implementers with the ability to validate the conformance of QRDA Category I and Category III documents to CMS implementation guides.
- CMS Quality Reporting System for eligible hospitals and critical access hospitals

### Where to Submit eCQMs

- Eligible Clinicians via <u>QPP</u> website must have a QPP account
- Eligible Hospitals and Critical Access Hospitals via <u>Hospital Quality</u> <u>Reporting</u> page – must have a <u>HCQIS (Health Care Quality</u> <u>Information Systems) Access and Roles Profile (HARP)</u> account

<u>Electronic clinical quality measures</u> (eCQMs) are measures specified in a standard electronic format using data electronically extracted from <u>electronic health records</u> (EHRs) and/or <u>health information technology</u> (IT) systems to measure the quality of health care provided. The Centers for Medicare & Medicaid Services (CMS) uses eCQMs in a variety of quality reporting and value-based purchasing programs.
