This document provides the versions of the standards and code systems used within the updated eCQMs for potential use in the Centers for Medicare & Medicaid Services (CMS) programs for the 2027 reporting/performance period. It is designed to prepare health information technology (HIT)/electronic health record (EHR) developers, eligible clinicians, and hospitals for 2027 reporting/performance through the transparent pre-release of the expected standards and code systems versions.

Where and when to obtain updated eCQMs for the 2027 reporting/performance period:

The eCQMs for the 2027 reporting/performance period will be available Spring 2026.
